## ROAD TRAFFIC

The A76 Trunk Road (Closeburn) (40mph Speed Limit) Order 2011

Made

*30th August 2011* 

Coming into force

8th September 2011

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 84(1)(a) and 124(1)(d) of, and paragraph 27 of Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a) and of all other powers enabling them to do so.

In accordance with section 84(2) of that Act(b) they have given public notice of their intention to make an order.

#### Citation and Commencement

1. This Order may be cited as the A76 Trunk Road (Closeburn) (40mph Speed Limit) Order 2011 and comes into force on 8th September 2011.

#### Restriction of speed

2. No person shall drive any vehicle at a speed exceeding 40mph on the length of road specified in the Schedule to this Order.

# THE A76 TRUNK ROAD (CLOSEBURN) (40MPH SPEED LIMIT) ORDER 1996

The Secretary of State, in exercise of the powers conferred on him (a) by sections 84(1)(a) and (2) and 124(1)(d) of the Road Traffic Regulation Act 1984(b) and of all other powers enabling him in that behalf, and having complied with Part II of the Secretary of State's Traffic Orders (Procedures) (Scotland) Regulations 1987(c), hereby makes the following Order:

- 1. This Order may be cited as the A76 Trunk Road (Closeburn) (40mph Speed Limit) Order 1996 and shall come into force on 13th December 1996.
- 2. No person shall drive or cause to be driven any motor vehicle on the length of road specified in the Schedule to this Order at a speed exceeding 40mph.
- 3. Paragraph 1 of the Schedule to the Trunk Roads (40mph Speed Limit) (Dumfriesshire) (Consolidation) Order 1975(d) is hereby revoked.
