The Scottish Ministers make the following Order in exercise of the powers conferred by sections 84(1)(a), and 124(1)(d) of, and paragraph 27 of schedule 9 of, the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 84(2)(b) of that Act, they have given public notice of their intention to make the following Order, and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(c).

#### Citation and commencement

**1.** This Order may be cited as the A87 Trunk Road (Breakish) (40mph Speed Limit) Order 202[ and comes into force on

2. No person may drive any motor vehicle at a speed exceeding 40 miles per hour on the length of road specified in the schedule.

#### Revocation

**3.** The Highland Regional Council (A850 Breakish, Skye) (40 mph Speed Limit) Order 1994(**d**) is revoked.

  - (b) vehicles being used in an emergency for coastguard purposes.

## SPECIFIED LENGTH OF ROAD

That length of the A87 Invergarry - Uig Trunk Road, from a point 48 metres or thereby northwest of the extended centre line of the U4792 Waterloo Road, Broadford, generally in a northeast direction to a point 318 metres or thereby northeast of the extended centre line of the C1238 Upper Breakish - Lower Breakish Road (Northeastern) junction for a distance of 3.88 kilometres or thereby.
